

# CRITERIA FOR PARTICIPATION

Vendors interested in participating in the Arkansas IT Contingent Labor Contract must initially register with CAI through the Supplier Management Portal, via the link below. If your company has already registered and has login credentials, you can log into the Portal via this link.

The Required Documentation outlined in this Criteria for Participation must be submitted as part of your enrollment within the Supplier Management Portal.

## **REQUIRED DOCUMENTATION:**

Please be aware that this documentation must stay current throughout the life of the contract for your company to actively participate in the program. The Supplier Management Portal will distribute automated alerts when your documentation is nearing expiration or has expired, and your company bears responsibility for maintaining the required documentation and will be inactivated if required documentation is no longer current.

#### COMPANY REGISTRATION

Your company must be registered to do business with the State of Arkansas and remain in a status of "Good Standing" for the duration of participation in the contract. Please provide a copy of the registration certificate.

Businesses located within the State will have received a certificate upon initially registering with the State.
